## Call for Entries

### ENTRY DETAILS

#### ELIGIBILITY

Open to all area artists age 18 and over. Work must have been completed in the last three years, must be original and shall not violate any ownership copyright. No giclees or reproductions will be accepted.

-- Artwork accepted in previous years is ineligible for entry. Work completed under the direct guidance of an instructor is also not eligible. -- Artwork does not have to be for sale. A 30% gallery commission will be deducted from artwork sold.

#### MEDIA and THEME

All media will be accepted.

#### PRESENTATION

All 2-D work must be framed and wired for hanging and cannot exceed 48" in width.

No saw tooth hangers. 3-D work must not exceed 200 pounds. Work not properly prepared for exhibition may not be accepted.

#### ENTRY FEES

**Artists of Rubber City members:** \$25 for up to two pieces and \$30 for three entries **Non-members:** \$30 for up to two pieces/ \$35 for 3 entries. Credit cards, cash, and checks are accepted. Make checks payable to: Artists of Rubber City

#### AWARDS

First, Second, Third and Honorable Mention cash awards will be given at the judge's discretion.
